Given my financial situation, should I choose an investment a brokerage service? Why or why not?

Hubble Investments LLC (“Hubble”) offers private placements to accredited investors and institutional investors. This is the only product that the firm offers.

How will you choose investments to recommend to me?

Hubble will provide you with information on the deals that are offered on the Propel(x) platform. We do our due diligence only on the deals that garner sufficient interest to cross the n=minimum thresholds. We may recommend some of the deals that are posted on the Propel(x) platform to some of our customers. Investors can make their own choices without a recommendation from Hubble.

What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?

All of our Registered Representatives are registered with FINRA and hold a Series 82 or Series 7 license, in addition to Series 63 licenses. Our Principals also hold Series 24 licenses.

Swati Chaturvedi, is our Co-founder and the CEO of Hubble Investments. She has been a management consultant, an investment professional and is now an entrepreneur. In addition to holding a FINRA Series 7 and Series 63 license, she is also a FINRA Registered Principal and holds a Series 24 license. She has an MBA from the Sloan School of Management, an M.S. from MIT, an M.S. from UC Berkeley, and a Bachelor’s degree from the Indian Institute of Technology, Roorkee.

Help me understand how fees and costs may affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

If you make a \$10,000 direct investment with Hubble, you would pay \$10,200. \$10,000 goes to the investment and \$200 goes to Hubble. If you make a \$10,000 syndicate investment, the pro-rated syndicate formation fees are deducted from your investment and the remaining amount would be invested in the private placement. Additionally, Syndicate investors will pay a carried interest (similar to a performance fee) if/when there is an exit event for their investment. Please note, these types of investments are highly risky, and not all investments may have an exit event.

How might your conflicts of interest affect me, and how will you address them?

Understanding the inherent conflicts, we have, how they could potentially influence our recommendations to you, and how we mitigate and disclose such conflicts is essential to your decision to use our services.

Hubble's affiliate Propel(x) Advisors manages a venture capital fund "the Newton Fund". This fund invests in many of the same private placements that are offered to investors. Investors should be aware that the firm, its employees or its affiliated fund may also participate in a deal.
